What is this product?

The Company is an open-ended fund with no specified maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The PRIIPs Manufacturer, Waystone Management Company (IE) Limited, is not entitled to terminate the product unilaterally.

Objectives

The investment objective of the Product is to seek to achieve an attractive return on capital while simultaneously attempting to limit the risk of capital loss. The Product is considered to be actively managed, which means that the Investment Manager is not constrained by any index or benchmark in the selection of investments. The Investment Manager has discretion in managing the investments of the Product. The Product seeks to achieve this objective by investment primarily in open ended collective investment schemes which gain exposure to equities (e. g. shares), Fixed Income Securities (with no restriction on the minimum credit rating), property, commodities and currencies. It is intended that the Product will maintain a balanced exposure to equities, Fixed Income Securities, property, commodities and currencies; however the Product may gain exposure of up to 85% of net assets to equities. Macro considerations will be used in determining the allocation of investments in order to achieve the Product's investment objective. Any income arising from this Share Class will be accumulated. The Product may use a number of simple derivative

instruments for investment purposes and/or efficient portfolio management purposes. Further information on the Product's use of derivatives can be found under the Derivatives section within the Product's Supplement. Although the use of derivatives may give rise to an additional exposure any such additional exposure will not exceed the Product's Net Asset Value.

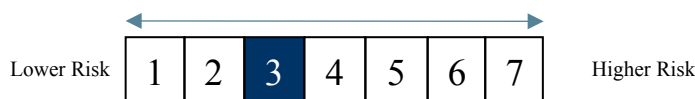

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

What happens if Waystone Management Company (IE) Limited is unable to pay out?

In the worst case, however, you could lose your entire investment.

Costs over time
