## What is this product?

### Type

The product is a share class of the sub-fund Templeton Global Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

Templeton Global Fund (the "Fund") is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term.

#### Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies of any size located in any country, including emerging markets

The Fund can invest to a lesser extent in:

- derivatives for hedging, efficient portfolio management and investment purposes

The investment team uses in-depth analysis to select individual equity securities that it believes are undervalued and will provide the best opportunities for increased value over the long term.

The investment team employs a binding proprietary Environmental, Social and Governance (ESG) methodology which is applied to all the equity holdings of the Fund (except for derivatives, ancillary liquid assets, bank deposits, money market instruments and money market funds) to determine a company's profile on relevant environmental, social, and governance issues. Furthermore, the Fund excludes from its portfolio issuers that score in the bottom 20% of the Fund's Investment Universe based on ESG Score using the MSCI ESG Ratings Methodology. The Fund also applies specific

exclusions and will not invest in companies that repeatedly and/or seriously violate the United Nations Global Compact Principles, manufacture nuclear or controversial weapons, derive certain thresholds of their revues from tobacco/tobacco products or from coal, oil sands extraction or coal-based power generation. The weighted average base ESG score of the Fund's portfolio is higher than the average ESG score of the companies in the Fund's Investment Universe, as measured by the ESG Score using the MSCI ESG Ratings Methodology.

**Benchmarks:** MSCI All Country World Index-NR (used for performance comparison purposes - neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat) and MSCI ACWI Investable Market Index-NR (used as a proxy for the universe, for the purpose of the ESG rating comparison). The Fund is not obliged to hold any of the benchmarks constituents and may significantly depart from the composition of these benchmarks.

#### Share Class Policy

For the distribution share class shown in this document, dividend income is distributed to shareholders.

#### Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

#### Intended retail investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to equity securities issued by companies worldwide and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

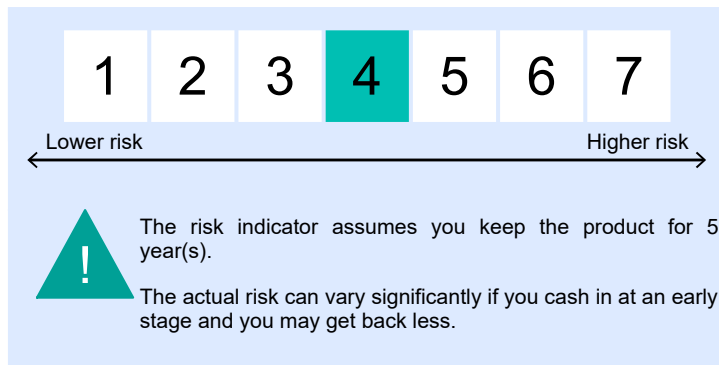

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
