## What is this product?

### Type:

The Fund is a sub-fund of Oaktree (Lux.) Funds (the "SICAV"), an investment company with variable capital structured as an umbrella fund offering a range of sub-funds.

### Term:

This product is not subject to any fixed term.

### Objectives:

The investment objective of the Fund is to achieve superior risk-adjusted returns by investing primarily in corporate high yield bonds, emphasising North American and European issuers.

The Fund is actively managed with reference to a benchmark ICE BofAML Non-Financial Dev. Markets HY Constr. (TR). While the Fund has a reference benchmark, it is actively managed by implementing the investment philosophy and process described herein and has an ample degree of freedom to deviate from the benchmark.

The Fund will not purchase debt securities or obligations rated Caa1 or below by Moody's and CCC+ or below by S&P, or purchase comparable non-rated debt securities or obligations, if immediately after and as a result of such purchase more than 35% of its NAV would be invested in such debt securities or obligations. The Fund may invest up to 10% of its NAV in Distressed Securities.

The Fund may use derivatives for hedging purposes.

### Intended retail investor:

The Fund may be appropriate for investors who want to invest in high yield bonds issued primarily by North American and European issuers. It is designed for long-term investors who understand and accept the risks of the Fund, and are able and prepared to sustain losses.

### Depository:

The Fund's Depository is State Street Bank International GmbH, Luxembourg Branch.

### Risk indicator

The assets of the Fund are held in safekeeping by its Depositary, State Street Bank International GmbH, Luxembourg Branch in line with applicable regulations. In the event of the Depositary's insolvency, the Fund may suffer a financial loss, however, this risk is mitigated to a certain extent by the fact the Depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation or guarantee scheme in place which may offset, all or part, of this loss.

## What are the costs?
