# What is this product?

#### Type:

The Fund is a sub-fund of Oaktree (Lux.) Funds (the "SICAV"), an investment company with variable capital structured as an umbrella fund offering a range of sub-funds.

#### Term:

This product is not subject to any fixed term.

#### **Objectives:**

The investment objective of the Fund is to obtain attractive risk-adjusted returns relative to the Morgan Stanley Capital International Emerging Markets Index Net.

The Fund is actively managed with reference to the Morgan Stanley Capital International Emerging Markets Index Net. While the Fund has a reference benchmark, it is actively managed by implementing the investment philosophy and process described herein and has an ample degree of freedom to deviate from the benchmark.

The Fund utilise a long-only investment strategy by investing primarily in equities and similar instruments issued by (a) companies which are part of the benchmark or (b) companies that have a country of risk which is included in the benchmark or is not classified by the World Bank as a high income country. In addition, the Fund may also make investments which do not meet the foregoing criteria.

The Fund will not invest more than 5% of its NAV in private placements that are both unrelated to listed securities and fail to convey near-term registration rights, in accordance with Article 41 (2) of the UCI Law. The Fund may invest up to 10% of its NAV in Distressed Securities. In addition, the Fund may invest in China A-Shares through institutions that have obtained the Qualified Foreign Institutional Investor ("QFII") status in the People's Republic of China ("PRC") and/or the Shanghai/Shenzhen-Hong Kong Stock Connect scheme.

The Fund may use derivatives for hedging purposes and investment purposes.

The Fund is classified as Article 8 within the EU Sustainable Finance Disclosure Regulation. Information about the environmental and social characteristics promoted by the Fund is available in the Fund Prospectus (www.oaktreesicav.com).

#### **Intended retail investor:**

The Fund may be appropriate for investors who want to invest in equities listed in emerging markets. It is designed for long-term investors who understand and accept the risks of the Fund, and are able and prepared to sustain losses.

The assets of the Fund are held in safekeeping by its Depositary, State Street Bank International GmbH, Luxembourg Branch in line with applicable regulations. In the event of the Depositary's insolvency, the Fund may suffer a financial loss, however, this risk is mitigated to a certain extent by the fact the Depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation or guarantee scheme in place which may offset, all or part, of this loss.

### What are the costs?
