What is this product?

Type:

The Fund is a sub-fund of Oaktree (Lux.) Funds (the "SICAV"), an investment company with variable capital structured as an umbrella fund offering a range of sub-funds.

Term:

This product is not subject to any fixed term.

Objectives:

The investment objective of the Fund is to generate superior risk-adjusted returns by investing primarily in U.S. dollar denominated corporate high yield bonds, issued by North American issuers. The Fund is actively managed with reference to a benchmark FTSE High-Yield Cash-Pay Capped Index. While the Fund has a reference benchmark, it is actively managed by implementing the investment philosophy and process described herein and has an ample degree of freedom to deviate from the benchmark. The Fund may invest up to 10% of its NAV in Distressed Securities. The Fund may use derivatives for hedging purposes.

Intended retail investor:

The Fund may be appropriate for investors who want to invest in high yield bonds issued primarily by North American issuers. It is designated for long-term investors who understand and accept the risks of the Fund, and are able and prepared to sustain losses.

Depositary:

The Fund's Depositary is State Street Bank International GmbH, Luxembourg Branch.

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

The assets of the Fund are held in safekeeping by its Depositary, State Street Bank International GmbH, Luxembourg Branch in line with applicable regulations. In the event of the Depositary's insolvency, the Fund may suffer a financial loss, however, this risk is mitigated to a certain extent by the fact the Depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation or guarantee scheme in place which may offset, all or part, of this loss.

What are the costs?
