WHAT IS THIS PRODUCT?

Type

The fund is a UCITS fund pursuant to the Swedish Investment Funds Act (2004:46).

Term

This fund has no maturity date. However, the board of directors may decide to close the fund under certain circumstances.

Objectives

The objective of Carnegie Likviditetsfond is to generate a stable and positive return.

The fund may invest its assets in interest-bearing transferable securities, money market instruments, fund units and accounts with credit institutions. The fund may also invest in derivatives in order to make the management of the fund more efficient. These may be used to make the management more efficient in order to reduce risks and costs and to increase returns and generate leverage.

The fund's assets shall be invested in interest-bearing securities and money market instruments issued by Nordic governments, municipalities, county councils, credit institutions and companies with a Nordic association. Issuers must have a high credit rating. Investments in securities and money market instruments in foreign currency are hedged against the SEK.

The average duration of interest rates may not exceed 12 months. The average maximum expiration may be a maximum of 24 months for all securities included in the portfolio. The fund may make use of derivatives to reduce foreign exchange risk. This means that the fund attempts to reduce the effects of currency fluctuations.

This fund is suitable for investors seeking a short-term investment with low risk before successively increasing their savings in more risky investments such as equity funds. The fund is also suitable for investors who believe they may need to make use of their savings in the near future and therefore want to

assure regular returns without exposure to unnecessary risk.

Benchmark: The portfolio is actively managed without reference to a benchmark.

Intended investor

This fund is suitable for investors seeking a short-term investment with low risk before successively increasing their savings in more risky investments such as equity funds. The fund is also suitable for investors who believe they may need to make use of their savings in the near future and therefore want to assure regular returns without exposure to unnecessary risk.

Other information

Depositary: Skandinaviska Enskilda Banken AB (publ)

Dividend income: This class is a capitalisation class meaning that income is reinvested. The unit class pays no dividends.

Conversion right: The investor has the right to convert his investment in units for units in the same fund. The investor can obtain information about how to convert in the prospectus of the fund.

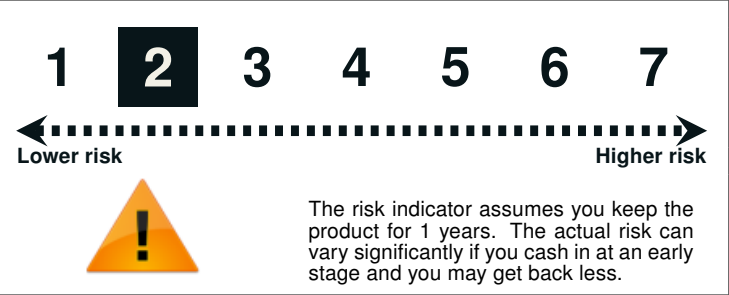

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Risks not captured by the risk indicator:
Liquidity risk: Low liquidity can make it difficult or impossible to buy or sell securities in reasonable time. Price may be lower or higher than expected.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

Moderate scenario: This type of scenario occurred for an investment between

December 2019 and December 2020.
Favourable scenario: This type of scenario occurred for an investment between October 2022 and October 2023.

WHAT HAPPENS IF CARNEGIE FONDER AB IS UNABLE TO PAY OUT?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depository Skandinaviska Enskilda Banken AB (publ). Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is part of another product, e.g. unit-linked insurance, there may be other costs for that product.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- You would get back the amount that you invested (0% annual return)
- 100,000 SEK is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 0.5% before costs and 0.1% after costs.

We may share part of the costs with the person selling you the product to cover the services they provide to you. They will inform you of the amount.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 years

You should be prepared to stay invested for 1 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. The fund is traded daily. Deposits into and withdrawals from the fund can normally be made on any weekday.
