Notwithstanding anything to the contrary contained herein we shall not be liable to pay any benefit in respect of a Member where payment in the event of a claim is directly or indirectly occasioned by, attributable to or in consequence of war, invasion, acts of foreign enemies, hostilities (whether war be declared or not), civil war, riot, rebellion, mutiny, revolution, insurrection, military or usurped power or confiscation or nationalisation by or under the order or any government or public or local authority or any act of any person acting on behalf or in connection with any organisation with activities directed towards the overthrowing by force of its government or to the influencing of it by terrorism or violence.
