The MSCI World Index includes stocks from developed countries worldwide which comply with MSCI's size, liquidity, and free float criteria. The index is free float market capitalization weighted. iShares ETFs are funds managed by BlackRock. They are transparent, cost-efficient, liquid vehicles that trade on stock exchanges like normal securities. iShares EFTs offer flexibility and easy access to wide range of markets and asset classes.
