### FUND STRATEGY

Through a blend of currency exposure combined with direct, absolute return and strategic bond fund holdings, the Fund aims to outperform the benchmark over the medium term. The use of a dynamic strategy as opposed to a benchmark tracking style should result in the Fund being well positioned as global bond markets move through the economic cycle.

The returns generated within the Fund will be from a combination of income, changes in asset prices, and currency fluctuations as the manager adjusts the Fund's asset allocation based on their global outlook of bond markets and their respective currencies. The Fund will frequently have significant international currency exposure on an un-hedged basis.
