## Appendix

**The information below aims at showing the range of currencies which is further made available for administration purpose, in respect of the New Investment-Linked Fund stated in the cover letter.**

As you are aware, investment-linked funds of Utmost International Isle of Man Limited (“Utmost International”) are further available in a range of currencies – US\$, £, HK\$ and €. Not every investment-linked fund is available in all four currencies. **Policyholders can only choose the investment-linked fund where by the available currency is identical to the policy’s denomination currency.**

Where the currency symbol (i.e. US\$, £, HK\$ or €) denoted in “multi-currency information” below has an asterisk (\*) next to it, the investment-linked fund prices are produced using our multi-currency pricing system. This means that we take the price of the base currency of the investment-linked fund and further apply the prevailing market exchange rate to it to produce the equivalent price in each of the other currencies which are further made available. In these cases, the value of the investment-linked fund will be subject to the exchange rate fluctuations.
